- 1. Admission to B.Tech programs shall be based on JEE/ CEE score or BSSRV-EE-2024.
- 2. Admission to BNYS, B.Sc. (Hons) Agriculture, B.Sc. (Hons) Horticulture and B.F.Sc. (Bachelor of Fisheries Science) shall be based on BSSRV-EE-2024.
- **3.** For Post Graduate programmes, candidates appeared/appearing in the Final Semester of the Qualifying Examinations, 2024 and waiting for their results are also eligible to appear in the **BSSRV-EE-2024** and can get provisional admission if selected.
- 4. Thetotal marks and duration of BSSRV-EE-2024 shall be 100 marks of 2 hrs duration.
- **5.** It shall be conducted in a single paper of the concerned subject containing 50 Objective Type Multiple Choice Questions (MCQ) carrying 2 (two) mark each.
- 6. The Question Paper shall be in English excluding the language subjects.
- 7. The **BSSRV-EE-2024** score shall be valid for admission in the current academic session 2024-25 only.
- 8. The BSSRV-EE-2024 shall be held in the Test Centres of the following places:

- a) Application for appearing in the **BSSRV-EE-2024** shall be through online mode only. No other means of application shall be accepted.
- b) For submission of the Online Application Form, candidates are advised to visit www.bssrv.ac.in or www.admission.bssrv.ac.in
- c) Go to apply online link.
- d) Candidates have to upload their signature, photo and Identity Proof in jpeg format.
- e) A valid mobile number and email address.
- f) Candidates have to deposit Entrance Test fees of Rs. 750/- for General/other category and Rs 500/- for SC/ST categories only at the below given Bank Details and have to upload the Bank Payment receipt (in jpeg Format) and Transaction_Id in the online application form. Note: (Any form of Electronic transfer is suitable e.g. UPI, Bank Deposit etc.)

13. Selection Procedure:

- a) It is **mandatory** for all the candidates to appear **BSSRV-EE-2024** to get admission into the above mentioned programmes.
- b) Merit list for provisional admission into the various programmes of BSSRV shall be based on performance in **BSSRV-EE-2024.**
- c) For candidate(**Results Awaited/ Appearing**) must have to produce an **UNDERTAKING** at the time of admission by mentioning that the candidate shall submit the relevant documents within the stipulated time fixed by the university. Admission of such candidate shall be purely provisional.
- d) Statutory Reservation and Relaxation Policy shall be followed as per the Government Rules.

<u>Note</u>:

- The University shall not verify the eligibility of the candidates at the time of receiving their Application Forms and Issuing Admit Cards to them. The candidates not fulfilling the minimum eligibility criteria may also appear in the BSSRV-EE-2024. However, if any of the details found incorrect during the document verification then, their candidature shall not be considered at the time of admission to the concerned Programme(s).
